SUMMER VIDEO LAB PERMISSION FORM

Myself and my child have read and understood the information regarding the Summer Video Lab, and I give permission for my child to participate in regular program activities, and visits to various filming locations as decided upon during the course of the program to fulfill the needs of each creative group's production process. During all program sessions, students will be accompanied by a program staff member. I realize that the North Vancouver District Public Library and the Pacific Cinémathèque Pacifique Society (Cinematheque) cannot be held responsible for students before or after session times (scheduled from 9:30am to approximately 3:30pm).

Lunchtime and break supervision will be provided for participants remaining on site, but parents/guardians have the option of permitting their child to leave the site and can indicate a preference below.

- I request that my child remains on-site from the start of the program until its end each day.
- My child is permitted to leave the site during lunch and break times each day.

In consideration of my child's participation in this program, I hereby release and discharge the North Vancouver District Public Library and the Cinematheque, and its representatives, successors, and assigns, from any and all liability arising from accident, injury, and illness that my child may suffer as a result of his or her participation. I and my child will follow the rules and regulations set by the North Vancouver District Public Library and the Cinematheque, and will alert program staff should my child have any medical conditions, allergies, or special educational needs that could impact his or her participation in the program, or require special attention by program staff members.

I hereby grant to you, the North Vancouver District Public Library and the Cinematheque and its partners and funders (collectively "the Producers") the absolute right and permission to use and re-use, in whole or in part, my child's name, voice, image, likeness, music and artwork produced or provided for use during the course of her/his participation in this program. Videos and artwork may be taken, filmed or made at any point during Summer Video Lab, by or for the Producers and their program participants, facilitators or funders, for use in any and all media worldwide in perpetuity, for any and all legal purposes, including advertising or promotion, without payment or notice to me.

I further consent that the Producers are the owners of all intellectual property rights to the artwork produced during this program, the videos, and all film, footage, recordings, soundtracks, images and reproductive product (including any digital reproductions) arising out of the videos and artwork (the "Intellectual Property"), and I hereby unconditionally waive any and all personal and proprietary right, including all moral rights, that I may have in the Intellectual Property.

It is understood that any such materials (video, audio, film, or any other media) will be used only for the purpose of promoting the projects, program, and program participants, at or for screenings, festivals, broadcast, media education workshops, program promotions events and online distribution. It is also understood that any such materials will be treated with the highest integrity and discretion, with the intent to communicate responsibly and ethically the subject matter contained therein.
